- 7. Discussion of financing options for the proposed street reconstruction projects.

City Council to consider potential financing options for the street reconstruction projects.

- a) Johnson introduced Todd Hagen with Ehlers and Associates to begin the discussion. Hagen discussed the findings and handed out materials addressing the comprehensive, long-range road reconstruction plans for the City. He stated there were various ways to finance the reconstruction through a five year Reconstruction Plan Bond Issuance, special elections, tax abatement bonds, assessments, etc. Hagen outlined the different state statutes that would apply and outlined the legal process that would take place for bids and public notification before the project could be started. Hagen stated the City is fortunate to have different options to consider. Hagen said the City had plenty of capacity for the project.
- b) Johnson asked if we had a public forum/ open session before the council meets, would this be something that Ehlers and Associates would host. Hagen stated that they could arrange a meeting to address questions from residents.
- c) Johnson asked the Council if there were any questions. Wenck asked if the projection was for 1.5 million for the project. Wenck reiterated that over five years 202 lots would be affected. He clarified that tonight was about choosing the process the City was going to go with.
- d) Johnson and Spencer discussed that there should be a Public Hearing before the Council Meeting May 12, 2015 with the Engineer and Public Works to answer any questions. Spencer stated it could potentially run from 5:30-7:30 p.m.
- e) Johnson stated the City would publish legal notices in the noted three papers and it would be a good idea to also publish a news release.

Motion by Wenck, second by Betts to approve a conceptual Resolution for Property Tax Abatement/ 10 year for Road Reconstruction and to direct staff/ attorney to publish the notice for a public hearing to consider the issuance of financing for the street reconstruction. 1) Lindgren Lane property discussion.
