7. Hennepin County Assessor David Thomsen – Present Preliminary Local Board of Appeals and Equalization Information In Preparation of April 3, 2018 Meeting.

Thomsen noted that Independence properties had an average increase of 1.7% based on previous year sales. Lower priced homes saw a larger increase than higher priced homes. Lakeshore increased on average at 5.2%, commercial +0.2%, industrial 1.1% and Ag decreased -0.4%. Thomsen said evaluations will be focused in the northeast corner of Independence this year as well as all agricultural within the City. The local board meeting will be held Tuesday, April 3rd at 6:00 p.m. The board has the ability to increase, decrease or make no changes on individual valuations. Thomsen stated they try to stay between 90-105% of market value.

8. Maple Plain Fire Chief Justin McCoy – Annual Fire Department Information Presentation.

McCoy thanked the Independence City Staff and WHPS for their support and help in 2017 in getting information to the public regarding MPFD. McCoy said there were 274 emergency calls in 2017 of which 176 were medical, 77 fire calls and 21 car crashes. McCoy said the busiest day of the year is Sundays. He noted average response time was 4 minutes 55 seconds. McCoy said they have 24 firefighters currently and will be looking to have more come on board. He stated the MPFD now has a website at www. mapleplainfire.com. McCoy said the training program has been enhanced to align with the Minnesota training board 11 elements.

McCoy noted a couple items coming up in 2018. He said they are writing a spec to replace tanker number 11. He noted it is an early 1980's model and they are in need of an upgrade. McCoy said they are looking at adding a Fire Inspector position to assist with fire safety inspections and business pre-plans.

McCoy said on April 23, 2018 they will be holding a fire fighter recruitment event/ open house. Anyone who has ever thought about being a firefighter is urged to attend and see what it is all about.
