Kroells stated there 1,051 incident complaints through the end of February of which 319 were in Independence. He said there were 1,702 incident complaints in March of which 393 were in Independence.

In addition to the modification made for the road, the applicant has noted that all of the Outlots will remain under the ownership of Hamilton Bros. Inc. Based on the direction provided by City Council at the last meeting and the amended preliminary plat, staff has prepared a resolution for consideration along with the ordinance rezoning the property.
