- 7. Presentation of the 2017 Financial Audit Chris Knopik, Clifton Larson Allen.
 - a. Fourth Quarter Financial Report

The complete report is available in the City Council packet available on the website

The audit for 2017 was presented and full details may be heard through LMCC link or the packet is available online as well. The largest component of the general fund is property tax revenues which are around 83-84%. Licensing and permits make up the next segment and came in around 240k in 2017. Grants and local government aid make up the remainder with other miscellaneous items. General fund expenditures have stayed proportionate year over year. Police and Fire are the largest expenditures and those services have stayed the same year after year. Johnson noted that number includes animal control as well. The City was able to collect 99% of its tax levy in 2017. Sanitary sewer saw an increase in revenue over the last year of about 20k due to new accounts and increased sewer rates. Sewer repairs were down in 2017. He noted there was a way to go but at least some of the operating costs were beginning to be recovered.

- 8. Consideration of Declaration of Easement for the Property Located at 2914 Lindgren Lane.
 - a. Consider Approval of Driveway and Utility Easement across the City's Property Located on Lindgren Lane.

Kaltsas said the property located at 2914 Lindgren Lane has historically been accessed via a shared driveway that runs along the northern boundary of the City's former community septic mound property. In 2010 and 2014, the City granted a driveway and utility easement across the shared driveway to the property located at 2906 Lindgren Lane. The 2914 Lindgren Lane property is in the process of being sold and the new owner is seeking a formalized driveway and utility easement to memorialize the historical access to their property as well as to allow them to connect to the stubbed sewer connection that is in

Lindgren Lane. The new owner will likely make application to the City in the future for a building permit to raze the existing home and construct a new home on the subject property.

The City is being asked to grant the same easement to the property at 2914 Lindgren Lane as it did to 2906 Lindgren Lane. The two property owners would need to privately work out a joint maintenance plan for the driveway. The City does not foresee any issues relating to the granting the aforementioned easements.

Motion by Spencer, second by McCoy to approve the Declaration of a driveway and utility easement across the city's property located on 2914 Lindgren Lane. Ayes: Johnson, McCoy and Spencer. Nays: None. Absent: Grotting and Betts. MOTION DECLARED CARRIED.
