MINUTES OF A WORK SESSION OF THE INDEPENDENCE CITY COUNCIL THURSDAY DECEMBER 12, 2019 –7:00 A.M.

Kaltsas gave an overview of what is being proposed for building improvements on a conceptual level. He stated phases of improvement could be looked at for budgeting purposes. Kaltsas stated the interior improvements are being proposed for the next year.

Susan Morgan with BKV Group introduced the project and the firm's background. She outlined the necessary improvements and also the noted cosmetic refresh improvements. Morgan addressed three primary aspects of the renovation.

- 1. Monetary
- 2. Identity
- 3. Functional

Kaltsas said opening the lobby area and making it flow into the community room would be much more welcoming. Morgan noted it could be a pre-function space where people gather before functions. She also said it could be a type of museum space to showcase City history. Spencer said it is nice to have the ability to wall off the Council chambers when other events are held so the room does not have to be arranged every time. West Hennepin Police area won't have many changes except a larger garage. Morgan said minimal changes to the exterior could make a big impact on impressions of the building. Kaltsas said Staff is working on the technology piece to lay it out so it is a fixed dollar amount.

Kaltsas said he is looking at a bond for \$3M for the City Hall improvements as well as the road projects. Bituminous roads that were not completed in the 2015 project will be over layed through this initiative. Staff is researching how best to treat road shoulders. There are issues with landscaping and sprinkler placement so gravel may be extended to address those issues. Staff would like to know how to address this initiative with residents should it be through an open house or letters of notification. Kaltsas estimates the cost to run around \$1.3-\$1.5M.

d. Highway 12/CSAH 92 Project Update and Discussion

Kaltsas, Johnson and Kroells met with Commissioner Kelliher who was very receptive and said she would talk to the Commissioners at the County to see about why they are not helping fund this initiative. A corridor study is being done so a roundabout that is in place needs to be considered as part of that if already completed. The corridor study will take a year and half. The current funds for improvement from the State need to be completed at some point in 2021. It is being determined if that means the contract in place or if the project itself needs to be completed by that deadline.

Discussion:

Staff has been working with MNDOT and Hennepin County to better understand the potential benefits and limitations of Alternative 3a with a bypass. The City has spent the last couple of months trying to find solutions that would allow Alternative 4G to become feasible or to secure additional funding. To this point Hennepin County and MNDOT have not been willing to explore ways to realize development of Alternative 4G. Staff has also met with several outside engineering firms to review the alternatives and analyze the findings, benefits and potential limitations of both alternatives.

Staff has identified the following key points for Council consideration:

- Alternative 3A with bypass will increase the average daily commute of eastbound traffic by 8-12 seconds per vehicle over Alternative 4G. Westbound traffic will have the same or negligible difference during peak times. In either alternative, the level of service (functionality) of the road will not drop below a high level of service.
- Alternative 3A with bypass will increase the potential daily conflicts (potential crashes)
 over Alternative 4G by approximately 60 per day. With either alternative, the potential
 daily conflicts versus the current road is greatly reduced. There will likely be an increase
 in the local cost to administer (police) the intersection for Alternative 3A with bypass. It is
 difficult to quantify the actual cost, but based on discussions with police departments with
 similar intersections, the number of incidents will increase.
- The City was concerned about limiting the future mobility of the corridor with Alternative 3A with bypass. Based on a variety of conversations, both alternatives will allow the expansion of the corridor in the future. The overpass is being designed to accommodate a four-lane intersection. If a four-lane intersection is considered, the roundabout could potentially be designed as a four-lane intersection.
- The bond funding that was secured to develop this project has an expiration date of approximately 4 years from the date of approval (May 2017 approval, May 2021 expiration). As a result of this limitation and the time required to design, acquire right of way and bid this project, the City will need to act on approving an alternative if we want to realize an improved intersection and corridor.

Council Recommendation:

Staff will review in more detail, the additional discussions relating to the intersection, design, limitations and benefits that were discussed over the past month at the City Council Meeting. Based on the discussions that have been had and the unwillingness of MNDOT and Hennepin County to fund Alternative 4G, staff will be recommending that the Council approve Alternative 3A with bypass.


