- 7. West Hennepin Public Safety Director, Gary Kroells, December 2019 Monthly Report.

Kroells stated there were a total of 6,491 incident complaints reported for Independence and Maple Plain through the end of 2019. For the month of December; 247 incidents occurred in Independence and 132 incidents were in Maple Plain.

- 8. Annual Consideration of Fee Schedule Amendments.
  - A. **RESOLUTION 20-0121-01** Considering the Annual Update to the City's Fee Schedule.

Kaltsas said the City annually reviews and adopts the City's fee schedule to ensure that the cost of providing various services is commensurate with the services provided. The City identified several fees that should be amended based on the costs of providing services and or administration of the fees in 2019. In addition, the City will increase quarterly sewer charges in accordance with the adopted Sewer Rate Study. After several years of steeper sewer rate increases, the City's anticipated sewer rates are beginning to flatten with more typical increases recommended. The following fees are proposed to be amended:

1. Right of way permit \$100 (\$75 in 2019)

2. Zoning Permit fee. The City reviews sheds and agriculture buildings for compliance with zoning ordinances (i.e. – setbacks, wetland impacts, height limitations, grading, etc.) even though a building permit is not required. The City typically spends ½ to 1 hour to review and approve these site plans. The City has been charging the review under miscellaneous services but would like to include the fee in the fee schedule.

a. Shed (120 SF or less), Ag Buildings \$40 (not specified previously)

3. Quarterly sewer charges are proposed to be amended in accordance with the City's sewer charge study that was updated in January of 2017. The City is in the process of updating the study for 2020. The updated study will be presented at an upcoming Council Meeting. The quarterly sewer fees will be amended for 2020 as follows:

a. Quarterly sewer access charge \$231 (\$220 in 2019)

b. Quarterly availability charge \$200 (\$150 in 2019)

Kaltsas noted there is an escrow added for assembly permits as a deposit for WHPS services. The deposit will be \$500. Kroells said there are several events that take place every year throughout the City that are on a large-scale requiring police presence. This escrow will ensure WHPS does not have to go back and collect after the event to recoup pay to cover police hours.

Johnson asked if SAC charges are increasing this year. Kaltsas noted they have not increased.

Brian VanBeusekom, 4985 Klaers Drive, said he was approached by a solar company about putting panels on his property. Johnson noted the Planning Commission has had several meetings about solar and felt that the City should remain limited due to public comments. He said the ordinance is in place for now and would have to be amended before any large solar gardens would be allowed in the City. Spencer noted residents were strongly opposed to solar panels in the City when it was presented several years ago. Kaltsas said community solar gardens are strictly prohibited. Council encouraged Mr. VanBeusekom to talk further with the Utility company and Administrator Kaltsas.

## City of Independence Reimbursement Resolution Discussion

#### Discussion:

The City is in the process of preparing plans and specifications for the 2020 Bituminous Street Overlay Project and possibly a City Hall improvement project. If the City determines it necessary and appropriate to issue bonds for the projects, certain costs associated with the development and preparation of plans and the projects in general could be reimbursed with proceeds from bonds. This enabling resolution does not obligate the City to issue bonds and or move forward with either of the potential projects. The majority of the potential costs to be reimbursement include professional services fees such as engineering and architecture which are required to prepare plans and specifications. The resolution allowing the City to reimburse certain costs was prepared by the City's legal counsel.

#### CITY OF INDEPENDENCE RESOLUTION NO. 20-0204-01

#### DECLARING THE OFFICIAL INTENT OF THE CITY OF INDEPENDENCE TO REIMBURSE CERTAIN EXPENDITURES FROM THE PROCEEDS OF BONDS TO BE ISSUED BY THE CITY

WHEREAS, the Internal Revenue Service has issued Treas. Reg. § 1.150-2 (the "Reimbursement Regulations") providing that proceeds of tax-exempt bonds used to reimburse prior expenditures will not be deemed spent unless certain requirements are met; and

WHEREAS, the City of Independence, Minnesota (the "City") expects to incur certain expenditures that may be financed temporarily from sources other than bonds, and reimbursed from the proceeds of a tax-exempt bond;

WHEREAS, the City has determined to make this declaration of official intent (the "Declaration") to reimburse certain costs from proceeds of bonds in accordance with the Reimbursement Regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF INDEPENDENCE, MINNESOTA AS FOLLOWS:

1. The City proposes to undertake the renovation of the city hall of the City and certain street reconstruction projects including but not limited to bituminous overlay along with crack repair, restriping and shoulder work on roads within the City including Stephanie Way, Brei Kessel Road, Merz Way Waldemar Way, Providence Place, Providence Court, Warren Way, Providence Curve, Providence Path, Turner Road, Polo Club Road, Copeland Road, Lindgren Lane, Independence Road, Budd Street, Fieldstone Place, Stone Court, Hillstrom Road, Drake Court, Drake Drive, Painter Creek Green and Timber Island Trail (collectively, the "Project").

2. The City reasonably expects to reimburse the expenditures made for certain costs of the Project from the proceeds of bonds in an estimated maximum principal amount of 2,615,000. All reimbursed expenditures will be capital expenditures, costs of issuance of the bonds, or other expenditures eligible for reimbursement under Section 1.150-2(d)(3) of the Reimbursement Regulations.

3. This Declaration has been made not later than sixty (60) days after payment of any original expenditure to be subject to a reimbursement allocation with respect to the proceeds of bonds, except for the following expenditures: (a) costs of issuance of bonds; (b) costs in an

amount not in excess of \$100,000 or five percent (5%) of the proceeds of an issue; or (c) "preliminary expenditures" up to an amount not in excess of twenty percent (20%) of the aggregate issue price of the issue or issues that finance or are reasonably expected by the City to finance the project for which the preliminary expenditures were incurred. The term "preliminary expenditures" includes architectural, engineering, surveying, bond issuance, and similar costs that are incurred prior to commencement of acquisition, construction or rehabilitation of a project, other than land acquisition, site preparation, and similar costs incident to commencement of construction.

4. This Declaration is an expression of the reasonable expectations of the City based on the facts and circumstances known to the City as of the date hereof. The anticipated original expenditures for the Project and the principal amount of the bonds described in paragraph 2 are consistent with the City's budgetary and financial circumstances. No sources other than proceeds of bonds to be issued by the City are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside pursuant to the City's budget or financial policies to pay such Project expenditures.

5. This Declaration is intended to constitute a declaration of official intent for purposes of the Reimbursement Regulations.
