- 7. Director Gary Kroells, West Hennepin Public Safety:

Kroells noted due to the snow in April there were a lot of traffic incidents. He said there has been an increase in phone scams and online thefts and urged citizens to monitor their accounts closely. Kroells stated there has been a rash of burglaries in Independence and surrounding areas by a group that gains access to unlocked cars and into homes.

Johnson asked if Kroells thought the meeting with the Commissioner would be helpful moving forward on Highway 12. Kroells said he thought it was a good meeting and now it would be necessary for the Transportation Commissioner to move forward with a plan, so it can be out for bidding. Kaltsas stated there would be an open house on July 11th from 5:00-7:00 p.m. regarding the plans.

8. Annual Opportunity for Public to Comment on MS4 Permit.

Kaltsas noted each year the City is required to offer an opportunity to the public to provide comments relating to the City's MS4 Stormwater Permit. No official public hearing is required.

What is an MS4?

A municipal separate storm sewer system is a conveyance or system of conveyances (roads with drainage systems, municipal streets, catch basins, curbs, gutters, ditches, man-made channels, storm drains, etc.) that is also:

• owned or operated by a public entity (which can include cities, townships, counties, military bases, hospitals, prison complexes, highway departments, universities, etc.) having jurisdiction over disposal

2 City of Independence City Council Meeting Minutes 6:30 p.m. June 18, 2019 of sewage, industrial wastes, stormwater, or other wastes, including special districts under State law such as a sewer district, flood control district or drainage districts, or similar entity, or an Indian tribe or an authorized Indian tribal organization, or a designated and approved management agency under section 208 of the Clean Water Act that discharges to waters of the United States;

- designed or used for collecting or conveying stormwater;
- which is not a combined sewer; and
- which is not part of a publicly owned treatment works.

The MS4 General Permit is designed to reduce the amount of sediment and pollution that enters surface and ground water from storm sewer systems to the maximum extent practicable. Stormwater discharges associated with MS4s are subject to regulation under the National Pollutant Discharge Elimination System/State Disposal System (NPDES/SDS). Through the MS4 General Permit, the system owner or operator is required to develop a stormwater pollution program (SWPPP) that incorporates best management practices (BMPs) applicable to their MS4.

9. Appointment of New Member to the Planning Commission.

Motion by Grotting, second by Spencer to approve RESOLUTION 19-0618-01 to appoint Anita Volkenant as a new Planning Commissioner. Ayes: Johnson, Betts, Grotting and Spencer. Nays: None. Absent: McCoy. MOTION DECLARED CARRIED.

10. Open/Misc.

Spencer noted the gun club will be grading this summer and by fall will be open for trap shooting.

Johnson asked about the letter regarding the Shriner property. Kaltsas said the City's water resource group looked at historical photos and it is not out of proportion due to a lot of water.
