Jon Dailing/Windsong Farm Golf Club (Applicant) and David Meyer (Owner) are requesting the following action for the property generally located at and adjacent to 8590 County Road 92 N (PID No.s 32-118-24-23-0001, 32-118-24-22-0003, 32-118-24-22-0002, 32-118-24-13-0002, 32-118-24-12-0003 and 32-118-24-12-0004) in the City of Independence, MN:
  - a. **RESOLUTION NO. 22-1018-01** Considering approval of a conditional use permit amendment to allow the development of a new 18- hole golf course and associated site improvements on the subject properties.

Kaltsas recapped packet pages 19-49. Conversion from AG to potential golf course to allow it to exist as a private golf course. Converting land on N side of 6 to a new 18-hole golf course. Zone AG and guided by public semipublic. It is a place holder zoning. We are leaving it as an AG property and considering this Conditional Use Permit/CUP amendment. The City approved North side to be developed as a practice facility and driving range in the past. Prior to that was overflow parking and tunnel under Co Rd 6. The Applicant wasn't interested in driving range plan but wanted to develop a new 18-hole golf course. In review of that the EAW kicked in requirement. AG converted to golf course triggered the EAW along with the acreage amount. A final resolution is required but we are waiting on some more info. There is no further environmental review required and with lack of comments relating to environmental impact, there is a negative declaration. Applicant is wanting to expand golf course with new 18-hole course on the North side

of their property, amending the CUP to expand the existing one. This is a second private course and utilized by membership in place or expansion of it. It includes a 1,400 sq ft seasonal starter house with 400 sq ft bathroom facility in the middle of the course. Those are the only 2 built buildings on North side. Additionally, they'd be expanding parking new driveway off Co Rd 6. We looked at parking and CUP and impacts. It would look and feel very similar to South side of Co Rd 6 with berming to screen from Co Rd 6 on both sides. We will have 3 adjacent golf courses with Pioneer golf course. There are 2 horse farms on the N and one on the E that it would abut. Demand for parking, natural resources, drainage, impacts. There is an extensive mitigation permit plan for a wetland, under ½ acre of 46 acres total. They are cutting and filling approximately 100 acres, moving 170 cu yds devoting 65 acres of turf grass which is typical. 92 new parking spaces being created. Our ratios of 5-6 spaces per hole (106 This would equate to 106 parking spaces required for the North course. The applicant has 137 parking spaces on the South side of Co Rd 6. The total number of parking spaces on both the North and South sides is proposed to be 237 spaces. The total number would exceed the general standard of approximately 212. This is reasonable as it will service a lot of their existing members. Similar to the South side, curb and gutter coming into the spaces. PC recommended bituminous paving this is permanent parking, not temporary. Parking lot proposed illuminated that would not spill out light outside of property boundaries. Watershed of the stormwater management plan needs to be approved. Our approval is subject to them finalizing it. The City received a couple verbal comments, none written. The PC recommendation to approve subject to the list of conditions and City approval. EAW comments are provided. We will make negative declaration through formal resolution.

Betts – You said seasonal buildings. Do they close that up in the Winter?

Jon- They will be like our existing bathrooms, waterlines drained and shut off.

McCoy – It is being identified as 18 Golf Walk; I think we should work with applicant for emergency calls to identify what side of the road. It would be nice to have some identifier to get responders to the right place quicker. They're all on the same phone system.

Johnson – Is there any water in Fox Lake?

Jon – Yes there still is.

Johnson – How often do the apartments get used?

Jon – It is used almost every single day. For meetings during the summer, on average they're used 4-5 nights a week.

Johnson – This golf course is slightly easier than the other one?

Jon – Yes. There isn't much water you are hitting the ball over. 3-4 par 3's. The green complexes can still be tricky but for all ages and skill level. Ever since Covid, golf became very popular. Now you need to set a T time.

Johnson – We do not need to rezone since it is under the AG zoning.

Motion by Grotting, second by McCoy to approve RESOLUTION NO. 22-1018-01 -to amend the conditional use permit for the Windsong Farms Golf Club located at 18 Golf Walk. Ayes: Johnson, McCoy, Betts, Spencer, and Grotting. Nays: None. Absent: None. Abstain. None. MOTION DECLARED CARRIED. 5:0

- <u>8.</u> Consideration of an amendment to Chapter II, Section 210.01 to align municipal elections with local, state and national election schedules.
  - a. **ORDINANCE NO. 2022-07** Approving an amendment to Chapter II, Section 210.01 of the Independence City Code.

Kaltsas - We have had this discussion a couple times on election cycle, we noted that the City is one of the few in the area that does an odd year election. We have fairly low voter turnout on odd years and quite a bit of resources used. School districts have been pulling out of odd years as well, so should we realign with them? Data going back shows that we have a 20% voter turnout vs. 80% voter turnout. So thousands of residents are not voting on local issues but are on statewide issues. Cost savings, staff resource savings, getting the most voters out are all being considered. Even year elections bring out significantly more voters. Independence has an 80% vote rate, which is very high. Local elections are 20% or less. We aren't capturing the voice of the people and that's why we are talking about it.

Johnson – In some of those higher years, it was a school levy bond referendum that brought out voters. Kaltsas – Mound Westonka is the only one that still has odd years, and they would just host their own if needed. All other districts are in even years now. Independence has 2,815 resident voters, and we consistently get in the 500's range for odd year elections, but in the even year elections, we get 2,200 voter turnout range. Cost issue of \$10-15k every election, requirements, staff time, trainings. There's never a good time to make a change and it will always impact election cycle, but we are in a non-election year so it wouldn't impact much.

Johnson – When you have odd year elections and there is no other election besides City elections, do the same rules apply as a normal election?

Kaltsas – Yes, the same rules apply.

McCoy – Does the cost include staff time?

Kaltsas – Physical dollars are tracked, \$5,000 are budgeted for election judges' time. Staff cost is not. But we spend weeks of staff time on trying to put on an election, trainings online, people at the window, ballots, etc. Time is hard to separate, staff multi-task. Requirements are more and more robust. We deal with it but with school districts changing and having low voter turnouts, questioning if we should align and additionally save some money.

Betts – I think this is logical and have been wanting to see this happen for a few years now.

#### Motion by Betts, second by Spencer to accept Ordinance No. 2022-07.

Johnson opened the Public Hearing.

Thompson shared concerns about the Orono school district issue with extending an extra year.

Johnson – That's what would happen too. Adding an extra year.

McCoy – For our next election cycle instead of 4-year terms, I'd rather do two 3-year terms than extend my term one year. We can't cut it short this year since it's too late, but I'd rather run for a 3-year term than extend myself a year. It'll take us longer to get there, but I do fully support have even year elections. Spencer – It would effectively extend everyone by 1 year. The only other way you can do it is to wait until

next year and vote for cutting terms to 3 years for the next 2 elections.

Kaltsas – You are going to have to offset somebody.

McCoy – We all get extended or cut to 3 years.

Spencer – If we didn't do it this year, we'd do it next year. We can't do it this year because it's too late. You could shorten your term next year.

McCoy – No, we expire. (Discussed cycle dates that were tricky.)

Spencer – Cutting terms running for a 3 yr term, now you see why most do it the other way to extend and we would need to be running 2 3-yr off year elections or extending everyone by one year. Now you see why most do it this way.

Betts – We save more money by doing it this way.

McCoy- Optics. I know.

Spencer – If we had political climate where we were filling the hall at all the Council meetings, I would worry about it more. Orono had contentious school board meetings. But this seems to be different. I don't know if the \$142 month. (laughter) The maybe it's self-dealing. It's very complicated to do it the other way. McCoy – I totally support moving to even year elections.

Betts- We are wasting money.

Spencer – It'll be pretty quiet with school district questions this year.

Johnson – We have a motion... I would like to see this tabled until our next meeting to see if any residents would comment on it. I know it was noticed and I haven't received any comments.

Spencer – I would agree with tabling it. If we did it within this calendar year.

Kaltsas – There isn't a rush on it.

Tabling it overrides the motion.

Motion by Spencer, second by McCoy to table Ordinance 2022-07 –Ayes: Johnson, McCoy, Betts, Spencer, and Grotting. Nays: None. Absent: None. Abstain. None. MOTION DECLARED TABLED. 5:0.

#### 9. Park Development and Hennepin County Facilities Grant Discussion.

Kaltsas – This is regarding a Pioneer Park improvement. We've tried to partner with some organizations historically to help with costs. We have had a couple different plans to make improvements. Hennepin Cty came out late Sept. /early Oct with a deadline of Nov 1 to apply for some grants. We haven't been able to put together a plan with any organizations to partner on a grant, but Orono youth baseball has been pretty serious. A special meeting prior to Nov 1 to pass a resolution would be needed if we want to move forward. The master plan shows some ideas to get the most out of it. Soccer field multi-purpose layout, seasonal parking, grading/drainage work to make them good fields. You can use it for T-ball, football, ultimate Frisbee, flag football, soccer, etc. Cost estimate associated is \$300k. It is not dividable. This is a possible project. We had discussions with Orono softball – 2 softball fields on the East side- a little over a year ago, not a lot of financial support from them. A smaller percentage would use it. Estimate was \$350k not including irrigation, lighting, benches, etc. Lots of earth work will be needed. Lastly, 2 tennis courts- know that pickleball has taken over and lots of interest. Engineers did 2 courts with estimate of \$330k. Asphalt, fencing, screening, and striped to convert to either court. The HN Cty grant funds up to \$300k targeted at youth sports. Goal of leveraging funds – we have \$199k where we could match them. You get scored on % of matching. We want to get that park utilized. We wanted to see if there was any direction towards one project over the other.

Johnson – Loretto had good luck for some of this.

Kaltsas – I think we would have a good shot at a grant. They like to disperse funds to those who haven't asked much.

Betts – What is one of the number one fields that is always in use? Soccer?

Kaltsas – All of the sports are looking for fields all of the time. We are split a little between Delano and Orono. Soccer is still looking for space. I haven't discussed as much with Delano organizations.

Spencer – I have had considerable amount of maintenance involvement, and I would love to see the soccer fields developed. But without a partnership with strong local organization funding, it is going to turn into a maintenance tail with the City to maintain it all. If we had a Orono soccer organization as a partnership to help maintain the facility. I don't think we have time to put anything like that together before Nov. 1. It can be expensive to take care of. That short turnaround time that rules out 2 of the 3. That leaves you with the tennis courts and pickleball. There's not a lot of maintenance with an asphalt pad. I would not put in a baseball field without having a partnership first.

Betts – Likely the tennis and pickleball courts would get a lot of use out of residents.

Kaltsas – Orono Baseball called last week. We have developments coming in with park dedication once they build out. We can start with a project and then do another project if we can come up with a partnership for another one. We are just trying to get the park used.

City of Independence

Spencer – We would have to do it in phases

Johnson – When do we need to have it built?

Kaltsas – Spring. We'd have to be ready to build it next year. With tennis courts, it would be harder to have youth interest. But you can put a basketball hoop on a tennis court as well. We won't stop trying to partner within the community. Softball really wants a 4-field cloverleaf, but we can only do 2. Baseball wants more than 1 but we don't have the space unless we redesigned it to be mostly baseball.

McCoy – 7-8 people reached out about softball/baseball in recent months.

Kaltsas - If you wouldn't build baseball, you could get a 3<sup>rd</sup> field in for softball. But then the \$350 for 2 without the extras.

Betts – I think we should pursue pickleball/tennis.

Johnson – Is that ok and then call a special meeting?

Spencer – Reach out to Delano and Orono Tennis to see if they would be interested Delano only has 3 courts. Both coaches would probably be interested or would write a letter of support.

McCoy – J Palmer might be willing to give it a once over. There's no concession stand on here and it would be worth having the relook at this.

Grotting - Are you going after highest volume sports?

Kaltsas – Mound-Westonka is the largest youth soccer approached us and broke down our city's numbers.

Re: parks - We had a resident that had passed away on Lindgren Lane and others had asked if they could put in a memorial bench, picnic table, or tree?

Spencer – Since we don't know what we are going to do with that City land, so something that would be able to relocate (bench or table) would be best.

SUBJECT: SEPTEMBER 2022 ACTIVITY REPORT

The purpose of this report is to give the reader a quick overview of the activities of the Public Safety Department each month. It also compares monthly and year-to-date information to the reader.

The report is broken down into five categories, as defined by the Criminal Justice Reporting System.

CRIMINAL-- Criminal is broken down into Part I and Part II crimes.

Part I includes crimes against persons versus crimes against property; criminal homicide, forcible rape, robbery assault, aggravated assault, burglary -breaking or entering, larceny-theft, larceny analysis, motor vehicle theft and arson.

Part II includes other assaults, forgery and counterfeiting, fraud, embezzlement, stolen property, buying, receiving, possession; vandalism, weapons, carrying, possessing, etc.; prostitution and commercialized vice, sex offenses; drug abuse violations, gambling, offenses against the family and children, driving under the influence, liquor laws, drunkenness, disorderly conduct, vagrancy, all other offenses, suspicion, curfew and loitering laws - persons under 18; and runaways - persons under 18.

TRAFFIC-- Includes violations of the road and driving laws.

PART III-- Lost and Found: Includes lost and found persons, animals, and property, and stalled and abandoned vehicles.

PART IV-- Casualties: Includes all motor vehicle accidents, boating, and snowmobile; public home occupational accidents, fires, suicides, sudden deaths, burning permits, and burning violations.

PART V-- Miscellaneous Public: Includes open doors, gun permit applications, suspicious activities, animal complaints, motorist assists, alarm calls, parking complaints, house checks, driving complaints, civil matters, family disputes, department assists.

The balance of the report shows the total number of incidents handled, miles driven and how the Public Safety Department received calls. If anyone should desire more detailed statistical data, please contact my office.



# **DIRECTOR'S NEWS & NOTES**

WEST HENNEPIN PUBLIC SAFETY September 2022 Activity Report

#### **Year to Date Activity Report**

At the end September 30, 2022, West Hennepin Public Safety (WHPS) handled year-todate a total of 3,558 incident complaints: For the month of September; 255 incidents occurred in the City of Independence and 101 in the City of Maple Plain.

The Criminal Part I and Part II cases for both cities have been highlighted for your review on the attached documents.

#### **Recent Highlighted Cases:**

Signal Problem September 1

5300 block of Highway 12, Maple Plain. Officer observed multiple pilons and traffic barrels that were struck and out of place for the detour around the construction. Officer replaced and restaged the pilons and barrels to correctly follow the detour.

Fire Alarm September 2

6100 block of Wood Hill Lane, Independence. Officer and MPFD were dispatched to a residential fire alarm. Officer and MPFD arrived and observed a light haze of smoke. It was determined to be a small electrical fire from an air exchange machine. MPFD ensured there was no further fire risk present.

# Smoke September 2

2000 block of Budd Street, Independence. Officer was dispatched to a residence for the smell of a burning candle or plastic in a garage. Officer and MPFD responded and observed some burnt paper and plastic near a work bench. No other fire hazard.

Open Bottle September 2

200 block of County Road 92, Independence. Officer observed a vehicle driving 50 in a 30 mile per hour zone. Officer discovered the driver's license was revoked and the passenger had an open bottle on the center console. Both parties cited for the violations.

#### Medical

#### September 2

4800 block of Gateway Blvd, Maple Plain. Officer was dispatched to a party that fell and was bleeding from the head. Officer arrived on scene with MPFD and North Memorial Paramedics. It appeared the patient had fallen when trying to get out of bed. Patient was transported to the hospital.

# Stolen License Plates

#### September 2

5200 block of Bryantwood Drive, Maple Plain. Officer was dispatched to contact the owner of a vehicle whose license plates were found in someone else's vehicle. Upon arrival, Officer made contact with the owner of the license plates and learned they had been stolen but not yet reported stolen.

#### Fall

#### September 3

Intersection of Luce Line Trail and Ingerson Road North, Independence. Officer was dispatched to a party who fell off a bike and went down into the ditch. Officer responded with North Memorial Paramedics and MPFD. The patient was located a mile east on the Luce Line Trail. North Memorial transported the patient to the hospital.

# Verbal Domestic

#### September 4

7300 block of Highway 12, Independence. Officer observed a male walking along Highway 12 in the road closed section. Officer made contact with the male who advised he and his girlfriend got into an argument. He advised he wanted space. The male was transported to Coborns in Delano to wait for his sister to get off work.

# Motorist Assist September 4

6000 block of Highway 12, Independence. Officer was on routine patrol in the area and observed a stalled vehicle. Officer made contact with the driver who advised she ran out of gas and didn't have any money or a phone. Officer provided the driver fuel.

# Sign Theft September 4

2200 block of South Lake Shore Drive, Independece. Officers took reports for signs that were stolen from resident's lawns. No surveillance video or suspect information.

# Suspicious Activity September 4

700 block of Copeland Road, Independence. Officer observed people standing outside of a car at a closed business with frequent damage to property. Officer identified the driver and learned the group was trying to see the aurora lights. Officer saw no harm and cleared.

# Pursuit September 5

Intersection of County Road 92 and County Road 6, Independence. Officer was conducting traffic enforcement in the area and observed a vehicle was driving 55 miles per hour in a posted 30 mile per house zone. Officer activated emergency lights and sirens to conduct a traffic stop and the vehicle continued to drive and took off at a high rate of speed and ultimately, initiated a pursuit. #### Request:

Kelly Brouwer (Applicant) and Al and Charlene Hatfield (Owners) are requesting the following action for the properties located at 3810 and 3850 County Line Road (PID No's. 07-118- 24-22-0002 and 07-118- 24-22-0006) in the City of Independence, MN:

a. A minor subdivision to allow a lot line rearrangement that would reduce the acreage of 3810 and increase the acreage of 3850 County Line Road.

#### Property/Site Information:

The subject properties are located at 3810 and 3850 County Line Road. There is an existing home and several small sheds located on the 3810 property. There is a non-conforming detached accessory structure on the 3850 property. The 3850 property is primarily comprised of tillable acreage wooded areas and several wetlands. Both properties are accessed from County Line Road.



#### Discussion:

The applicant approached the City about the possibility of adjusting the lot line between the two properties. In the existing condition, there are two 15 plus acre properties. The applicant is proposing to take a portion of the south property (3810 - ~11 acres and combine it with the north property 3850). This would reduce the south property to approximately 2.75 acres and increase the north property to ~31.50 acres. The City allows lot line rearrangements in the Agriculture zoning district.

Upon review of the existing properties, it was noted that there were several existing wetlands located on the subject properties. The ordinance allows a minimum lot size of 2.5 acres of buildable upland excluding wetlands) As a result of the probable wetlands, the applicant completed a wetland delineation to verify buildable upland acreage.

There are several factors to consider relating to proposed minor subdivision as follows:

## 3810 County Line Road

 The applicant has completed and received approval of the wetland delineation. The proposed property has approximately .05 acres of wetlands. The applicant is proposing a minimum lot size

- of 2.5 acres of buildable upland by accounting for the wetlands and County Line Road right of way (.05 acres wetlands and .21 acres of right of way).
- The City will require drainage and utility easements around the property perimeter and around the wetlands and requisite wetland buffers.
- The property has 264 lineal feet of frontage in both the before and after conditions. The minimum frontage required for properties between 2.50 acres and 3.49 acres is 200 lineal feet. In the before condition, the property did not meet the minimum frontage requirements for a ~15.00-acre parcel and was considered to be a legal non-conforming property. In the after condition, the property would have more than the required minimum frontage.
- The applicant has provided a report verifying a secondary on-site septic system.
- There is an existing shed located on the west side of the existing house that meets applicable building setbacks and is less than the allowed square footage for detached accessory structures.
- The existing home meets all applicable building setbacks in the before and after conditions.

#### 3850 County Line Road

- There is an existing detached accessory structure located on the subject property without a principal structure. This property is considered legal non-conforming. The proposed lot line rearrangement would not change the status of the property in the after condition.
- The applicant has provided a report verifying a primary and secondary on-site septic system.
- The City will require drainage and utility easements around the property perimeter and around the wetlands and requisite wetland buffers.
- No change in property access is proposed as a result of the lot line rearrangement. Any future access requests would be subject to the review and approval of Hennepin County.

The proposed minor subdivision to allow a lot line rearrangement brings 3810 into compliance with applicable frontage requirements and does not change the conformity of the 3850 County Line Road property. There do not appear to be any adverse impacts resulting from the proposed lot line rearrangement.

#### **Neighbor Comments:**

The property owner to the south of the subject property attended the public hearing and noted that they were concerned about changes to the property that would impact the existing drain tile that ran from her property to the north and west. Commissioners noted that the proposed subdivision to adjust the lot line would not in and of itself impact the drain tile and encouraged the property owner to reach out to the owners of the subject properties. Commissioners found that the criteria for approval of a minor subdivision were satisfied by the applicant and recommended approval to the City Council.

#### Planning Commission Discussion and Recommendation:

Planning Commissioners discussed the request and asked questions of staff and the applicant. Commissioners asked for clarification relating to the total acreage calculations and the 2.5 minimum acre requirement. Commissioners noted that

- The applicant shall provide the revised exhibit and corresponding drainage and requisite utility

- 3. The applicant shall pay for all costs associated with the City's review and recording of the requested minor subdivision.



#### **Election Cycle Ordinance Amendment**

#### Discussion:

City Council discussed this issue at its last meeting and recommended tabling the item to allow more time for public comment. Council discussed phasing in the date change but noted that this would prove difficult and lengthy as you would have to temporarily adjust Mayor and Council Member terms (from 4 to 3 years), hold multiple elections, and then switch terms back (from 3 to 4 years) in order to align with even year elections. There are other scenarios that could also be considered relating to term limits but would be similarly confusing. The example process would take 6 years to complete and would require that the City continue to hold annual elections For example:

2023 Election: Mayor and Two Council Members – <u>switch to 3- year term</u> (to 2026)

2024 Election: National Election

2025 Election: Two Council Members – switch to 3-year term (to 2028)

2026 Election: Mayor and Two Council Members – switch to 4- year term (to 2030)

2027 – No Election

2028 Election: Two Council Members – switch to 4- year term (to 2032)

City Council has held several discussions relating to the current election year cycle for municipal elections. The City has noted that there are several known issues relating to holding local elections in odd years. The following has been noted by the City:

Low voter turnout: the City has discussed whether or not the current local election schedule best serves the City's residents. The City has reviewed the last 20 years of voter turnout for local elections and noted that voter turnout is approximately 20% (off all registered voters) as compared to voter turnout during even year elections which is close to 80%. The City has 2,815 registered voters and consistently see more than 2,000 vote during even year elections. The City Council noted that increasing voter turnout would promote more public engagement in local decision making (sample of recent election turnout below).

- Off the four-school district represented in Independence, all but one have recently switched to even year elections. Adjusting the City's election schedule would align with school district voting schedules. It should be noted that if Mound Westonka had an odd year election, the City would not be responsible for hosting the election.

- The cost of hosting an election: the City is continually looking at how to provide efficient and cost-effective government. An average election costs approximately \$10,000-\$15,000 depending on a variety of factors. This estimate of cost includes staff hours that are often difficult to account for due to the increasing complexity, documentation, and expansion of the voting system. Removing odd year elections would reduce costs and increase available staff time for City residents.

#### Council Direction:

The City Council has discussed this issue several times over the course of the last year and noted that there is not an "ideal" time to make a change to the local election schedule. The Council has the ability to amend the City's ordinance and subsequent election schedule. Adoption of an amendment would cause for a shift in the current Council Member terms by aligning with the new election date (i.e., 2023 election shifts to 2024).

# AN ORDINANCE AMENDING THE CITY OF INDEPENDENCE CITY CODE, CHAPTER II, ELECTIONS, SECTION 210.01, WHEN HELD IN ORDER TO ALIGN WITH STATE, LOCAL AND SCHOOL DISTRICT ELECTION SCHEDULES

## THE CITY OF INDEPENDENCE, MINNESOTA DOES ORDAIN:

Section 1. The City of Independence City Code Chapter II, Section 210.01 be amended to as follows:

#### **SECTION 210 ELECTIONS**

#### 210.01. When held.

The regular city election shall be held biennially on the first Tuesday after the first Monday in November in every odd-even-numbered year.

Section 2. Effective date. This ordinance shall be and is hereby declared to be in full force and effect after its passage and publication according to law.
