#### 9. <u>OPEN/MISC.</u>

#### Brenno

Brenno, resident, read a statement regarding the most recent Police Commission meeting. She stated the residents do not want to contract with Hennepin County for police services. Brenno stated she thought she had assurance from some members of the Council that the issue would not be brought up again and had requested it be noticed if it were to come up. Brenno expressed a concern that the issue was brought up at a Police Commission meeting, which residents do not typically attend. She told Wenck she was annoyed that he brought the issue up again and told the rest of the Council to stop allowing the issue to be brought up.

Wenck stated that before the Council meeting in which police services were discussed, the Council held a Board of Review meeting where all of the residents who spoke stated their property taxes were too high. He noted that 14 people, two who were not residents, spoke at the Council meeting afterward. He stated that based on the e-mails and telephone calls he received in support of contracting with Hennepin County, he does not believe the residents are united in their opinion. Wenck stated that the group Friends of Independence has intimidated people so that they will not speak at meetings about the police department. Wenck stated that at the Police Commission meeting, he reiterated his position regarding the budget and police services. He added the residents currently pay \$40 per house for Sherriff services that are rarely

used, in addition to the \$600 per house for West Hennepin Public Safety. Wenck stated that no discussion took place at the Police Commission meeting regarding this issue.
